### High-level political forum on sustainable development

Convened under the auspices of the Economic and Social Council 9–18 July 2019

# Report of the high-level political forum on sustainable development convened under the auspices of the Economic and Social Council at its 2019 session

### Summary

In her summary of the high-level political forum on sustainable development convened under the auspices of the Economic and Social Council at its 2019 session (E/HLPF/2019/8), the President of the Economic and Social Council reported that, according to the review by the forum of progress in implementing the 2030 Agenda for Sustainable Development, the world is not on track to achieve the Sustainable Development Goals. While the 2030 Agenda and the Goals remain the best road map for overcoming the challenges to ending poverty and achieving sustainable development, a deeper, more ambitious, transformative and integrated response is urgently needed. The international community must move out of its comfort zones to pursue new ways of collective action at a much swifter pace.

Inclusive and equitable quality education for all is critical and demands new platforms for cooperation, new partnerships, more support for teachers and increased investment in universal quality education and lifelong learning.

Decent work and economic growth are dynamically interlinked in the Goals and are a means for achieving the 2030 Agenda. New technologies including artificial intelligence, automation and robotics offer both new challenges and opportunities in this area. Special efforts are needed to integrate youth, women and vulnerable groups into the labour market.

Inequality between and within countries remains a major obstacle to the achievement of the Goals, and inaction in that area risks derailing progress on the 2030 Agenda. Effective polices to reduce inequalities require partnerships and political will.

Progress on combating climate change and its effects is falling far short of what is needed. Achieving Goal 13 is still within reach, but implementation of existing commitments needs to be accelerated and the level of ambition raised substantially.



Peace, justice, and transparent, effective, inclusive and accountable institutions, as well as safe civic spaces, are critical to advancing all Goals. This demands responsive, inclusive, participatory and representative decision-making at all levels. Efforts are also needed to improve data in this area.

Substantial gaps remain for financing the Goals. National resource mobilization is needed, including through an enabling environment for private investment, strengthening tax administrations and addressing illicit financial flows. Integrated national financing frameworks can support countries in addressing financing challenges. Significant resources can also be mobilized at the regional level.

Overall, the Goals must be more systematically incorporated in plans and policies, with a focus on prioritization and acceleration of progress through interventions that have potential multiplier effects. An ambitious decade of action will ensure a new trajectory for achievement of the Goals.

Partnerships and international cooperation are fundamental in supporting small island developing States to achieve their sustainable development goals, particularly in the areas of health and education. Development strategies in least developed countries and landlocked developing countries must target goals beyond economic growth and encompass aspects related to inclusiveness, equality, universal social services, resilience to climate change, and adequate financing.

In particular, investment in data and capacity is needed for adequate measurements to inform policies that ensure no one is left behind.

Strengthening the role of non-State actors is also vital, and meaningful stakeholder engagement should include broad, inclusive consultations and the establishment of formal mechanisms for sustained stakeholder engagement in implementation of the Goals, in preparations for and discussions of voluntary national reviews at the high-level political forum.

Science can guide Governments in shaping policies that address the interactions among the Goals – the co-benefits and the difficult trade-offs – in a way that will spur positive systemic transformations. The *Global Sustainable Development Report* is an important tool in that regard.

### I. Introduction

- 1. The General Assembly, in its resolution 67/290, decided that the meetings of the high-level political forum on sustainable development under the auspices of the Economic and Social Council would be convened annually by the President of the Council for a period of eight days, including a three-day ministerial segment. Pursuant to paragraph 11 (c) of the annex to Assembly resolution 68/1, the three-day ministerial meeting is to be held during the high-level segment of the Council.
- 2. The Council, in its resolution 2019/1, decided that the forum would be held from 9 to 12 and 15 July 2019 and the high-level segment of its 2019 session from 16 to 19 July, including the three-day ministerial meeting of the forum from 16 to 18 July.
- 3. In its resolution 70/299, the General Assembly decided that the theme of the 2019 session of the forum would be "Empowering people and ensuring inclusiveness and equality" and that the forum, without prejudice to the integrated, indivisible and interlinked nature of the Sustainable Development Goals and with a view to facilitating an in-depth review of progress made on all Goals over the course of a four-year cycle, would review Goals 4, 8, 10, 13 and 16 in depth, in addition to its annual review of Goal 17.
- 4. The present report reflects the proceedings of the forum convened under the auspices of the Economic and Social Council at its 2019 session.

### II. Proceedings of and action taken at the forum

- 5. From 9 to 18 July 2019, the forum held 23 meetings, composed of opening, wrap-up and closing meetings, discussions on the review of Sustainable Development Goals 4, 8, 10, 13, 16 and 17 and on the thematic review, as well as 47 voluntary national reviews. The forum also held a general debate on its theme within the framework of its three-day ministerial meeting during the high-level segment of the Council (see paras. 190 and 191 below).
- 6. A total of 253 side events, 10 sustainable development learning courses and 5 special events, as well as other related activities, were held on the margins of the formal meetings of the forum and were sponsored by a diverse group of stakeholders, including Governments; agencies, funds and programmes of the United Nations system; international and intergovernmental organizations; and major groups and other relevant stakeholders. Information on the events is available on the website of the forum (https://sustainabledevelopment.un.org/hlpf/2019).

### Opening of the forum

7. At the 1st meeting, on 9 July, the President of the Economic and Social Council, Inga Rhonda King (Saint Vincent and the Grenadines), declared open the high-level political forum on sustainable development convened under the auspices of the Council at its 2019 session and made opening remarks.

- 8. At the same meeting, the Vice-President of the Council, Valentin Rybakov (Belarus), presented messages from the Integration Segment of the Council held on 8 July, and the Under-Secretary-General for Economic and Social Affairs, Liu Zhenmin, made opening statements.
- 9. Also at the same meeting, keynote addresses were made by the Special Representative of the Secretary-General on Violence against Children, Najat Maalla M'jid; author and commentator from the United Kingdom of Great Britain and Northern Ireland, Chris Skinner; and the founder and Executive Director of Island PRIDE and One Young World Ambassador from the Federated States of Micronesia, Yolanda Joab.

### Wrap-up session of the first week and conclusion of the forum

- 10. At the 15th meeting, on 15 July, a wrap-up session was held to reflect the discussions of the first five days, during which the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs of the Department of Economic and Social Affairs, Maria-Francesca Spatolisano, made a statement.
- 11. At the same meeting, the President of the Council presented her observations and highlighted key messages from the first five days of the forum.
- 12. At the 23rd meeting, on 18 July, at the conclusion of the forum, the Deputy Secretary-General of the United Nations, Amina Mohammed, made a statement.
- 13. At the same meeting, the President of the Council made a statement and declared closed the high-level political forum on sustainable development convened under the auspices of the Council at its 2019 session.

#### Adoption of the draft report

14. At its 23rd meeting, the forum adopted its draft report (E/HLPF/2019/L.1) under agenda item 3 (Adoption of the report) and agreed to entrust the President of the Council with finalizing the report to reflect the proceedings of the forum.

### III. Empowering people and ensuring inclusiveness and equality

15. The proceedings of the forum under agenda item 2, Empowering people and ensuring inclusiveness and equality, are set out below.

### Interactive discussions on the topic "Progress, gaps and obstacles: are we on track for leaving no one behind?"

16. At its 2nd meeting, on 9 July, the forum held an interactive discussion on the topic "Progress, gaps and obstacles: are we on track for leaving no one behind?", in two parts, chaired by the President of the Council.

#### Part I: Where do we stand?

- 17. During the discussion, the Under-Secretary-General for Economic and Social Affairs presented the report of the Secretary-General entitled "Special edition: progress towards the Sustainable Development Goals" (E/2019/68).
- 18. The discussion was moderated by the Executive Director for Policy at the United Nations Foundation, Minh-Thu Pham, who made a statement.
- 19. Presentations were made by the following resource persons: President, National Institute of Statistics and Geography, Mexico, Julio Santaella; Auditor General of Costa Rica, Marta Acosta; Special Representative and Permanent Observer,

20. ### Part II: Who is at risk of being left behind?

- 21. During the discussion, a keynote address was made by the Professor and Co-Director of the World Inequality Lab and of the World Inequality Database at the Paris School of Economics, Lucas Chancel.
- 22. The discussion was moderated by the Executive Director of the United Nations Institute for Training and Research, Nikhil Seth, who made a statement.
- 23. # Interactive discussion on the topic "What are regions telling us about the implementation of the 2030 Agenda for Sustainable Development and the Sustainable Development Goals?"

- 26. At the 17th (A) meeting, held in parallel with its 17th (B) meeting, on 16 July, the forum held an interactive discussion on the topic "What are regions telling us about the implementation of the 2030 Agenda for Sustainable Development and the Sustainable Development Goals?", which was chaired by the President of the Council and moderated by the Executive Secretary of ECLAC. The forum heard the reports by the ministerial chairs on the outcomes of the regional forums on sustainable development.
- 27. - 34. The representative of the Statistics Division of the Department of Economic and Social Affairs made a presentation on the statistical data related to Goal 4.
- 35. The forum viewed a video presentation on young students at Le Lobby de Poissy, a group of young environmental activists.

- 159. During the ensuing discussion, the Minister for Planning responded to comments made and questions posed by the representatives of Norway, Germany, Cameroon, Denmark and the major groups for women and non-governmental organizations.
- 160. A presentation on behalf of Israel was made by the Minister for Environmental Protection and Minister for Jerusalem Affairs and Heritage, Zeev Elkin and other presenters.<sup>2</sup>
- 161. During the ensuing discussion, the Minister for Environmental Protection and Minister for Jerusalem Affairs and Heritage responded to comments made and questions posed by the representatives of Austria, Argentina, the State of Palestine, Australia, Czechia and the major group for non-governmental organizations.
- 162. A presentation on behalf of Timor-Leste was made by the Minister for Legislative Reform and Parliamentary Affairs, Fidelis Leite Magalhães and other presenters.<sup>2</sup>
- 163. During the ensuing discussion, the Minister for Legislative Reform and Parliamentary Affairs responded to comments made and questions posed by the representatives of Thailand, the Central African Republic, Australia, Canada, China and the major group for non-governmental organizations.

- 164. A presentation on behalf of the United Republic of Tanzania was made by the Minister for Finance and Planning, Philip Mpango.
- 165. During the ensuing discussion, the presenter responded to comments made and questions posed by the representatives of Finland, Lesotho, Denmark, Canada, Kenya and the Democratic Republic of the Congo.
- 166. A presentation on behalf of Vanuatu was made by the Minister for Foreign Affairs, International Cooperation and External Trade, Ralph Regenvanu.
- 167. During the ensuing discussion, the Minister for Foreign Affairs, International Cooperation and External Trade; the Head of Monitoring and Evaluation of the Department of Strategic Planning, Policy, Aid and Coordination at the Ministry of the Prime Minister in Vanuatu, Juliette Hakwa; and the Permanent Representative to the United Nations, Odo Tevi, responded to comments made and questions posed by the representatives of Tuvalu, Canada, Norway, Papua New Guinea, Belize, Fiji and the major group for non-governmental organizations.

#### Voluntary national reviews: Cameroon and Tunisia

- 168. At the 21st meeting, on 18 July, presentations on voluntary national reviews by Cameroon and Tunisia were chaired by the President of the Council.
- 169. Presentations were made on behalf of Cameroon by the Minister for the Economy, Planning and Regional Development, Alamine Ousmane Mey, and on behalf of Tunisia by the President of the General Committee for Sectoral and Regional Development at the Ministry of Development, Investment and International Cooperation, Belgacem Ayed.
- 170. During the ensuing discussion, the presenters responded to comments made and questions posed by the representatives of Norway, Mexico, Oman, the Congo, Morocco and Libya, the observer for the Islamic Development Bank Group, the Resident Coordinator for Cameroon, the Executive Secretary of ESCWA, the Resident Coordinator for Tunisia and the representatives of the major group for women and the other stakeholders group for education and academia.

### Voluntary national reviews: Congo, Nauru, Oman, Mauritius, Guyana and Liechtenstein

- 171. At the 22nd meeting, on 18 July, presentations on the voluntary national reviews by the Congo, Nauru, Oman, Mauritius, Guyana and Liechtenstein were chaired by the President of the Council.
- 172. A presentation was made on behalf of the Congo by the Minister for Planning, Statistics and Regional Integration, Ingrid Olga Ghislaine Ebouka-Babackas.
- 173. During the ensuing discussion, the presenter responded to comments made and questions posed by the representatives of the Niger and Cameroon.
- 174. A presentation was made on behalf of Nauru by the Minister for Finance and Sustainable Development, David Adeang, and other presenters.<sup>2</sup>
- 175. During the ensuing discussion, the Minister for Finance and Sustainable Development responded to comments made and questions posed by the representatives of Australia, Norway, the Solomon Islands, Fiji and the major group for non-governmental organizations.
- 176. A presentation was made on behalf of Oman by the Minister for Commerce and Industry and Vice-Chairman for the Supreme Planning Council, Ali Masoud Ali Al Sunaidy, and other presenters.<sup>2</sup>

- 177. During the ensuing discussion, the presenters responded to comments made and questions posed by the representatives of Tunisia, Estonia, Pakistan, Norway, India, the observer for the Islamic Development Bank Group and the representative of the major group for workers and trade unions.
- 178. A presentation was made on behalf of Mauritius by the Minister for Foreign Affairs, Regional Integration and International Trade, Nandcoomar Bodha.
- 179. During the ensuing discussion, the presenter responded to comments made and questions posed by the representatives of Canada, the Federated States of Micronesia, Uruguay, India, Rwanda and the other stakeholders group for persons with disabilities.
- 180. A presentation was made on behalf of Guyana by the Minister of State, Dawn Hastings-Williams and other presenters.<sup>2</sup>
- 181. During the ensuing discussion, the presenters, as well as the Chairman of the Private Sector Commission, Gerald Gouveia, responded to comments made and questions posed by the representatives of Norway, Belize, Jamaica, Canada, China, Cabo Verde, ECLAC, the United Nations Resident Coordinator in Guyana, and the representative for the other stakeholders group on ageing.
- 182. A presentation was made on behalf of Liechtenstein by the Permanent Representative to the United Nations, Christian Wenaweser and other presenters.<sup>2</sup>
- 183. During the ensuing discussion, the presenters responded to comments made and questions posed by the representatives of Mexico, Argentina, Indonesia, Zambia and the other stakeholders group on education and academia.

#### Voluntary national reviews: Mauritania and Turkmenistan

- 184. During the 23rd meeting of the forum, on 18 July, presentations on the voluntary national reviews by Mauritania and Turkmenistan were chaired by the President of the Council.
- 185. A presentation on behalf of Mauritania was made by the Minister for Economy and Finance, El Moctar Ould Djay.
- 186. During the ensuing discussion, the presenter responded to comments made and questions posed by the representatives of Canada, the Dominican Republic, Senegal, ESCWA and the major group for non-governmental organizations.
- 187. A presentation on behalf of Turkmenistan was made by the Minister for Finance and the Economy, Batyr Bazarov, and other presenters.<sup>2</sup>
- 188. During the ensuing discussion, the Minister for Finance and the Economy responded to comments made and questions posed by the representatives of Uzbekistan, Belarus, Kyrgyzstan, Tajikistan, Norway, Kazakhstan, Romania and China.

#### D. General debate

189. The forum held its general debate from 16 to 19 July, within the framework of the ministerial meeting of the forum during the high-level segment of the 2019 session of the Council.<sup>3</sup>

190. The general debate heard 196 statements, composed of 139 statements by representatives of States and the European Union (including 16 statements on behalf of groups of States), 15 statements by observers for intergovernmental organizations and representatives of specialized agencies and other entities of the United Nations system, and 42 statements by representatives of non-governmental organizations, major groups and other stakeholders.

### IV. Organizational and other matters

191. At its 1st meeting, on 9 July, the forum adopted its provisional agenda (E/HLPF/2019/1):

192. The forum was attended by representatives of 167 States Members of the United Nations and States members of specialized agencies. Accredited observers for intergovernmental organizations, representatives of organizations of the United Nations system and accredited representatives of non-governmental and other organizations also attended.
