End poverty in all its forms everywhere

SDG TARGET	UNDRIP ARTICLE

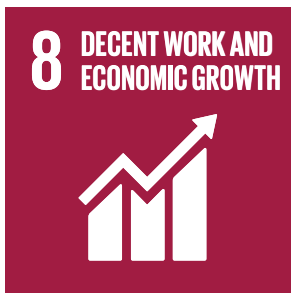

Promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all
